CB&LF is a Covenanted ministry of the UCC. "Our vision is to transform communities by helping the Church live into God's economy. We assist new and renewing congregations of the United Church of Christ—and other Christian denominations in the United States—with programs and services that help a congregation plan, raise, finance, and build projects, including property and social enterprises, that advance the mission of the church." CB&LF was born right around the time South Church was! It was founded in 1853 by American Congregationalists to support the mission of building churches and church renewal.

# **Amistad Redevelopment Corporation (ARC)**

The Amistad Redevelopment Corporation (ARC) is an Ohio-Based nonprofit organization, affiliated, and wholly controlled by the Local Church Ministries Church Building & Loan Fund. In other words, ARC is a redevelopment wing of the UCC's Local Church Ministries CB&LF and works specifically with PIV. Their address is the UCC Headquarters address in Cleveland, Ohio.

### Partners in Vision (PIV)

Partners in Vision (PIV) is a program created by the Church Building & Loan Fund (CB&LF). "The Partners in Vision program offers planning and technical assistance on major projects involving church property. We help your church create a plan that is resourceful, sustainable, creative and mission focused—assisting with project management, pre-development, repurposing church owned property that is unused or underused, planning complex projects and charting a course for real estate in transition."
